This does not include prepackaged food that is not prepared on site. T.C.H.D. is closed on Fridays

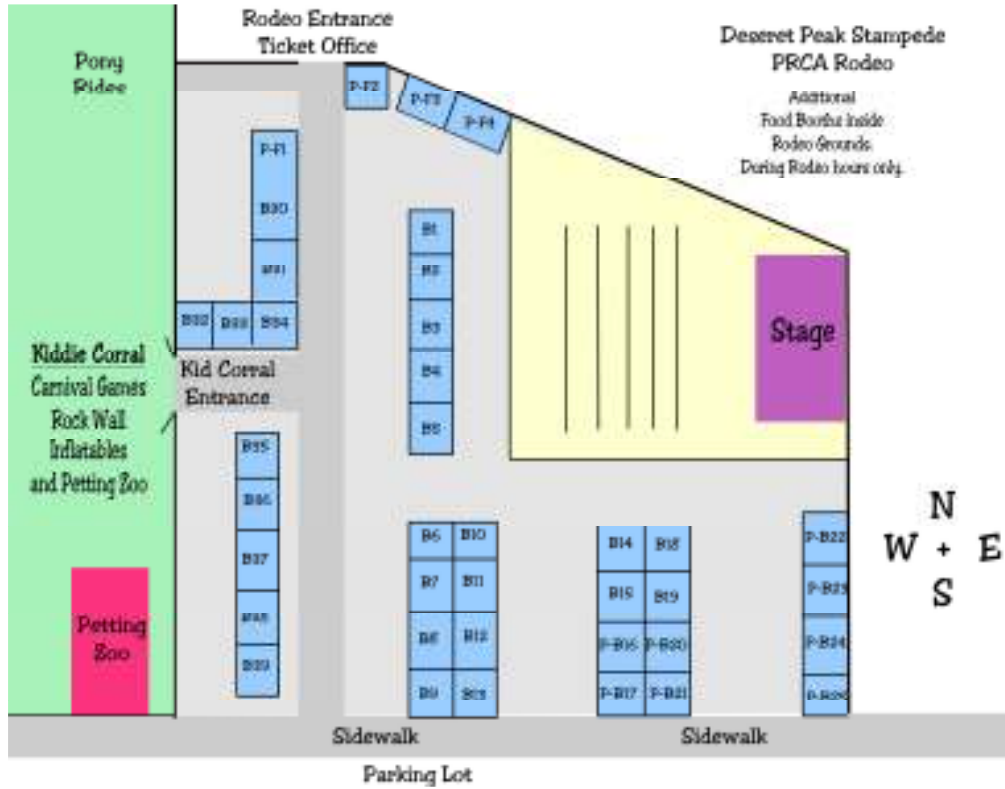
